Re: "Couples Therapy" – Notice of Breach of Contract

Dear Brian:

Our office represents Irwin Entertainment, Inc.

Reference is hereby made to the Participant Agreement, Release and Arbitration Provisions dated as of October 7, 2013, as revised on October 22, 2013 (the "Agreement"), between Irwin Entertainment, Inc. ("Irwin") and Brian Martin Dawe ("you") in connection with your participation on the fourth cycle of the television show currently referred to as "Couples Therapy" (the "Series"). On October 3, 2013, our office was informed by Robin Roth that you intended to participate in the Series along with your girlfriend, Farrah Abraham. Our office issued the Agreement and began legal negotiations with your manager, Martin Wells, on October 7, 2013. Pursuant to Martin's October 25, 2013 email (on which you were copied), the fully negotiated Agreement and an accompanying addendum were approved for signature and we were assured that you would be arriving in Los Angeles, California on Sunday, October 27, 2013 to render on-camera services in connection with the Series.

Our client, Irwin, relied on the repeated representations made by both yourself and your manager that you and Farrah Abraham were in a relationship and that you desired to participate in the Series. Irwin has expended significant amounts of time and money in reliance on those representations as well as your acceptance of the terms of the Agreement, which was conveyed to our office by your manager as stated above.

Be advised that Irwin reserves the right to pursue any and all claims for damages incurred by Irwin and/or Viacom Media Networks due to any misrepresentation and/or fraud on your part regarding your intent to participate in the Series and/or your relationship with Farrah Abraham. Notwithstanding the foregoing, you may cure your current breach of the Agreement by reporting to set to render on-camera services on the Series no later than October 29, 2013.

We sincerely hope that this matter can be resolved without the need of legal intervention. Your fans are undoubtedly eager to have the opportunity to get to know you and Farrah better, and, in addition to negatively impacting any future relationship and/or opportunities with Irwin and/or Viacom Media Networks, your failure to participate as agreed will surely disappoint them.
