

On the 11TH day of MAY, 2016 at 08:24  A.M.  P.M. (Specifically include facts constituting cause for arrest.)

On Wednesday, May 11, 2016, at or about 8:24 p.m., Riviera Beach Police units were dispatched to 2525 Lake Drive Riviera Beach, Florida 33404, in regard to a burglary in progress. The burglary occurred on a vessel (1990/XDC FL/DO# FL1071PM) which was docked on the west side of the property.

Upon arrival, Officer M. Menard met with Thomas Zelinsky (victim), Christopher Malone (witness/ property manager), Willis Lawson (witness), Joan Goodmaster (witness), and Aaron Glee (suspect). Glee was sitting in a chair on the vessel when I made contact with the aforesaid witnesses. Glee immediately uttered that he got on the wrong boat but was unable to give information on what boat he was given permission to board. Glee was immediately detained pending further investigation.

The following is a synopsis of what was reported by the victim and the witnesses via sworn recorded interviews:

On this report date at or about 2 p.m., Joan Goodmaster entered her fiancée's vessel to do her laundry. Goodmaster noticed that the inside of the vessel was in disarray and became concerned that an unknown person maybe aboard the vessel. She notified the property manager (Christopher Malone) and they inspected the vessel together. Malone discovered a back pack and clothing which belong to Glee. The back pack contained several documents which indicated Glee's name.

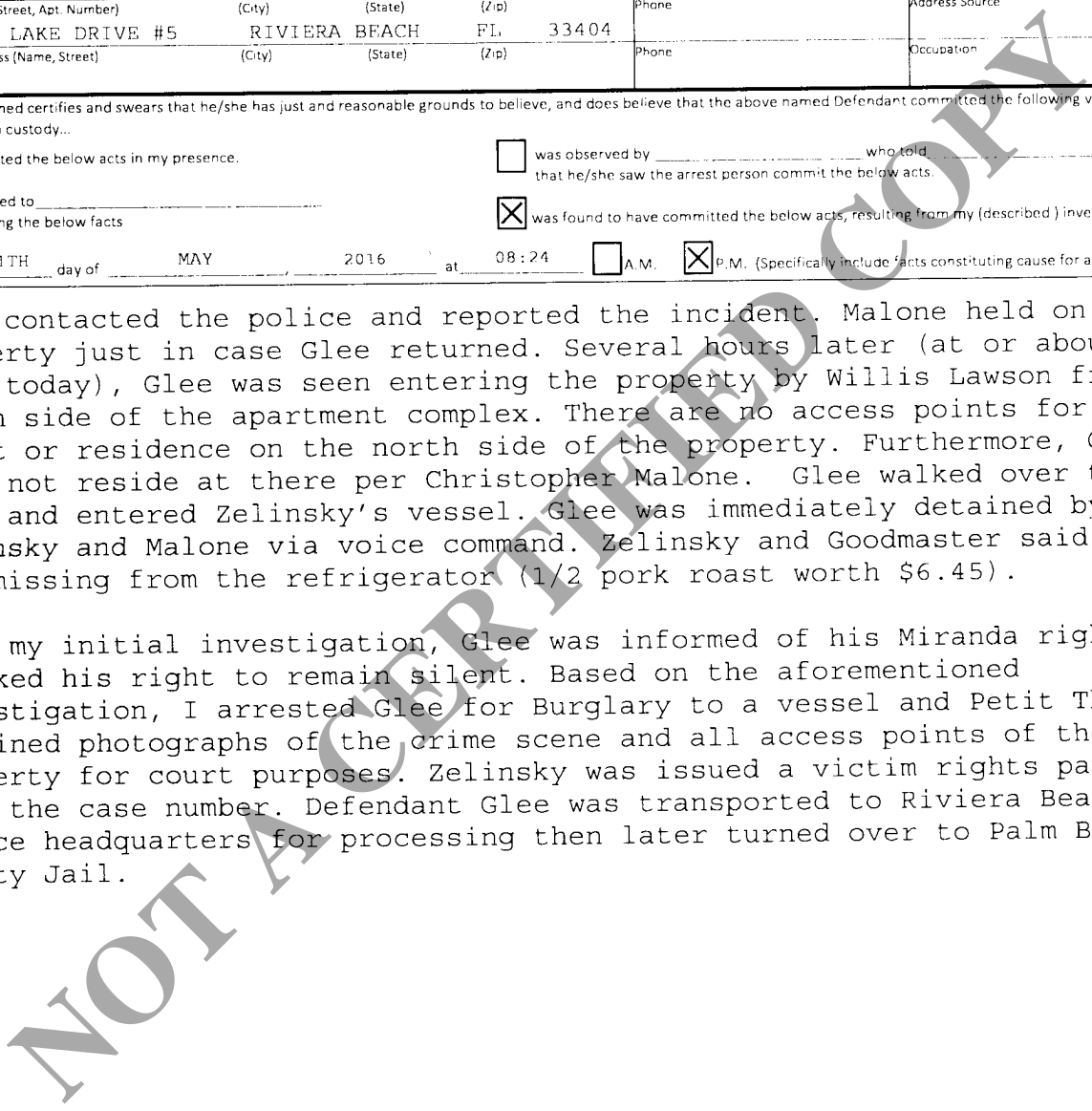

On the 11TH day of MAY 2016 at 08:24  A.M.  P.M. (Specifically include facts constituting cause for arrest.)

They contacted the police and reported the incident. Malone held on to the property just in case Glee returned. Several hours later (at or about 8:15 p.m. today), Glee was seen entering the property by Willis Lawson from the north side of the apartment complex. There are no access points for the guest or residence on the north side of the property. Furthermore, Glee does not reside at there per Christopher Malone. Glee walked over to the dock and entered Zelinsky's vessel. Glee was immediately detained by Zelinsky and Malone via voice command. Zelinsky and Goodmaster said food was missing from the refrigerator (1/2 pork roast worth \$6.45).

Upon my initial investigation, Glee was informed of his Miranda rights but invoked his right to remain silent. Based on the aforementioned investigation, I arrested Glee for Burglary to a vessel and Petit Theft. I obtained photographs of the crime scene and all access points of the property for court purposes. Zelinsky was issued a victim rights pamphlet with the case number. Defendant Glee was transported to Riviera Beach Police headquarters for processing then later turned over to Palm Beach County Jail.
