On 12/14/2018 at approximately 1328 hours, I (SRO M Malgrat) was notified by a teacher that a student had just battered her.

I met with Ashley Henriquez who told me a student, [REDACTED], had battered her while in class. Henriquez stated she was supervising a class in the lunch room (PE) and had to speak to [REDACTED] several times. Henriquez stated [REDACTED] was not sitting properly on the bench seat. Henriquez stated that she asked [REDACTED] several times to sit properly because she was concerned for his safety. After several times to get [REDACTED] to comply, she finally asked him to come sit by her. Henriquez stated that [REDACTED] refused to come sit by her and she got up and walked over to him. Henriquez stated [REDACTED] told her "don't put your hands on me" as she went to escort him to where she was. Henriquez stated as she started "walk with me" [REDACTED] began to curse at her and told her, "my mom is going to beat your ass". Henriquez stated [REDACTED] then punched her in the chest with his right hand.

As Henriquez was entering the front office, I observed that [REDACTED] had his hands clinched into fists and he was postured as if he was ready to fight.

Henriquez did not sustain any obvious injuries as a result of the punch from [REDACTED].

Contact was made with [REDACTED]'s mother, [REDACTED], who was currently traveling back from Miami. [REDACTED]'s father [REDACTED] was contacted and responded to the school.

[REDACTED] was placed in custody and was transported to MCDC for processing by Ofc Waite and Ofc Sims.

Based on the facts of the case there is probable cause to believe that [REDACTED] did violate FSS 784.081(2c) by actually and intentionally striking Henriquez against her will. Henriquez is employed by the Monroe County School District as a licensed teacher.

My BWC was uploaded to the server.
