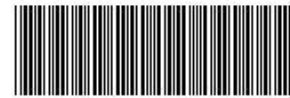

THE DEFENDANT UPON OFFICERS ARRIVAL SPONTANEOUSLY STATED THAT METH HAD SCREWED UP HIS LIFE AND THAT HE STABBED HIS WIFE. OFFICERS LOCATED AN UNKNOWN WOMEN UNRESPONSIVE LAYING ON THE FLOOR COVERED IN BLOOD WITH STAB WOUNDS.

LIEUTENANT AUB PRONOUNCED THE VICTIM DECEASED AT 0438 HOURS.

FURTHER INVESTIGATION REVEALED THAT THE DEFENDANT WAS THE 911 CALLER AND STATED ON THE 911 CALL THAT HE HAD KILLED HIS WIFE WITH A KNIFE.

THE DEFENDANT WAS TAKEN INTO CUSTODY WITHOUT FURTHER INCIDENT AND TRANSPORTED TO THE CITY OF MIAMI POLICE HOMICIDE OFFICE FOR QUESTIONING.

POST MIRANDA THE DEFENDANT STATED THAT HE HAD GOTTEN INTO A VERBAL ARGUMENT WITH THE VICTIM. THE DEFENDANT STATED THAT THE VICTIM AND HIM WERE ARGUING AND HE BECAME ANGERED AFTER SHE HAD STATED THAT SHE HAD A BETTER MAN THEN HIM. THE DEFENDANT ADVISED THAT HE WENT TO THE KITCHEN AND GRABBED A KNIFE AND A FORK AND RETURNED TO THE ROOM WHERE THE VICTIM WAS LAYING DOWN ON THE BED. THE DEFENDANT PROCEEDED TO PUSH THE VICTIM TO THE FLOOR FROM THE BED, AND STABBED HER MULTIPLE TIMES UNTIL HE REALIZED WHAT HE HAD DONE. THE DEFENDANT STATED THAT HE DESERVES THE PUNISHMENT THAT COMES TO HIM.

A SEARCH WARRANT WAS WRITTEN AND EXECUTED FOR THE INCIDENT LOCATION.

CITY OF MIAMI CRIME SCENE RESPONDED AND DOCUMENTED THE SCENE.

A BLOODY KNIFE AND FORK WERE LOCATED INSIDE THE INCIDENT LOCATION.
