<p>In the City of Riviera Beach, Palm Beach County, Florida, the following incident was captured on an AXON2 Body Worn Camera:</p> <p>On the above date at approximately 22:27 hours, I observed a tall white male wearing a multi-colored camo type jacket and blue jeans acting suspiciously by approaching young girls (approximately 15 years of age), pacing back and forth and sweating profusely.</p> <p>As I drove around the block to regain visual observation of the individual (later identified as David E. Anthony), I observed him opening the door of a black 2016 Nissan Frontier bearing Florida Tag IC64HH. The vehicle was backed into a parking space in front of the Two Drunken Goats Restaurant located at 2509 N. Ocean Ave.</p> <p>I parked approximately 10 spaces to the South of the vehicle so I could walk up and observe the individual without his knowledge. As I approached the location of the truck, I noticed the rear running lights were illuminated indicating the vehicle was running. I was unsure at this time if Anthony was within the vehicle due to dark tint on the windows. As I was running the tag, Anthony exited the vehicle and walked away northbound along the walkway. At this point I activated my body worn camera.</p> <p>Anthony then returned and I noticed there was black electrical tape placed over the numbers of the tag in such a manner as to alter the number's appearance (changing the 6 to an 8). Upon questioning Anthony about the altered tag, he stated his step daughter probably did it, because she's 12 and likes to play with tape. He began acting extremely nervous, by repeating himself, standing up and down and pulling the tape off.</p> <p>He then quickly walked up to the driver's door while saying "Am I being detained or can I go". He then stated "I'm just getting my license". I told him "Do not get anything out of your car sir". He then yanked the door open and began reaching under the area of the</p>



front driver's seat floorboard.

I then drew my duty weapon and ordered him out of the vehicle and onto the ground. At this point in time Anthony exited the vehicle, sat on his buttocks and showed me his hands. I kept Anthony at gunpoint until Officer J. Jones #6680 arrived on scene. I told Ofc. Jones to detain Anthony, at which time she attempted to handcuff him. Anthony then leapt up and dove into the car and repeatedly slammed the door on Ofc Jones' left arm as Jones was trying to pull him out of the vehicle and stop him from reaching around for an unknown object.

Eventually Jones was able to get Anthony out of the vehicle as Sgt. M. Dodson arrived and helped to subdue Anthony who was holding an unknown object in his right hand. Sgt. Dodson executed several brachial strikes at which time Anthony dropped the unknown item onto the ground. Sgt. Dodson then took Anthony to the ground after losing his radio from his duty belt during the struggle.

Anthony was then handcuffed and placed under arrest without further incident. He was transported to Police Headquarters for processing, then transported to the Palm Beach County Jail to be booked for Resisting an Officer with Violence.
