**CCN #20176594 – PUBLIC NARRATIVE**

BWC Activated.

The following statement is based on my best recollection without having the legal authorization to review any associated BWC footage to assist in writing this statement.

On Saturday, 12/12/2020, at approximately 2100 hours, officers working First Amendment demonstrations in the District of Columbia responded for a fight in progress.

Upon arrival, officers located V-1, V-2, V-3, and V-4, all suffering stab wounds. V-1 identified S-1 as the person who stabbed him.

Further investigation revealed a video from the NY Post showing S-3 push S-1 in the back, at which point S-1 produces a knife, and S-4 then pull on S-1's mask repeatedly, at which point V-2/S-2 punches S-1 repeatedly in the head.

V-1, V-2, V-3, V-4, and S-1 were all transported to local hospitals.
