***AFFIDAVIT FOR ARREST WARRANT***

Electronically, the undersigned Judge F. Allen electronically, Detective Shawn Dozier of the Oakland Police Department, who by me being first duly sworn, says that on the 13th day of November, 2021 in Oakland, Orange County, Florida, the Defendant, **Zackary Latrell Stacy** did in violation of **Florida State Statute 784.045** unlawfully commit the criminal offense **Aggravated Battery a 2<sup>nd</sup> degree felony**; **Zackary Latrell Stacy** did in violation of **Florida State Statute 806.13. (1)(b)(3)** unlawfully commit the criminal offense **Criminal Mischief 3<sup>rd</sup> degree felony**,

On November 13, 2021, Field Training Officer Castro and Officer Ribeiro were dispatched to 419 W Hull Avenue in response to a domestic disturbance. Upon arrival, they met with Corporal Crews, interviewing Kristin Evans, the victim.

Officer Ribeiro observed Ms. Evans appeared to be emotionally distraught with tears in her eyes. She was sitting on the couch in the living room where the incident occurred. Evans's shirt was torn, and she had food in her hair. The television was knocked over and damaged after the perpetrator threw the victim into it, and the remote was broken on the floor. Food was spilled all around the living room, and the baby's bouncy chair was knocked over and broken.

Evans stated she was "extending an olive branch" to her son's father, Zachary Stacy Sr since they had been in mediation and allowed him to visit Zack Stacy Jr.

He sat on the couch eating breakfast around 2:20 p.m. when they started arguing, and he got physical with her. He struck Evans on the right side of her head and picked her up, and threw her against the television, causing it to crack and fall over. While Evans was on the floor, he continued yelling at Evans and striking her while she got up from the floor, picked her up again, and threw her onto the baby's bouncy chair. Stacy then walked out the front door, and Evans called 911.

Evans requested E.M.S., and Orange County Rescue 37 was dispatched to the scene. Evans refused to be transported. Officer Ribeiro took photographs of Evans and the scene. Surveillance video of the living room, showing the incident, was uploaded to evidence.com by a department-issued body camera.

Officer Ribeiro gave Ms. Evans a Victim's Rights brochure and Marsy's Law pamphlet. Ms. Evans completed a sworn written statement and has been attached to the offense report. Ms. Evans expressed she wished to press charges against Mr. Stacy.

Kristin Evans and Zachary Stacy have one child together; Zachary Stacy Jr. Ms. Evans (D.O.B. 6/12/21) is also the mother of Kimberly Hall (D.O.B. 2/3/09). Both children were present when the incident occurred. The Department of Children and Families (D.C.F.) was notified, and a report was taken by D.C.F. Agent Shan, ID#210, on 11/13/21. Shan informed me the incident would be investigated.

Officer Rebeiro was not able to locate Zachary Stacy at the time of the initial report.

My investigation revealed the following:

On November 16, 2021, I conducted a follow-up interview with Ms. Kristin Evans, a complainant/victim involved with this case. As a result, I went to Ms. Evans's employment at the Serenity Spa located at 355 Citrus Tower Boulevard in Clermont, Florida. Additionally, I interviewed Ms. Evans to gather further information in regard to the case. The interview was recorded utilizing a department-issued body camera.

At approximately 0915 hrs., I started the interview with Ms. Evans. She stated in sum and substance that her ex-boyfriend Zackary Stacy (perpetrator) contacted her via text message that he wanted to go to her home to visit the child they have in common. Ms. Evans stated that when Mr. Stacy arrived at her home, she allowed him entry, and he had bought breakfast for her and the child. Ms. Evans also stated that Mr. Stacy started to speak to their child, who is five months old, and stated that the visit would be the last day that he would visit with him. After speaking to his child, Mr. Stacy then focused his attention on Ms. Evans. He accused Ms. Evans of cheating on him with a friend they have in common. The friend was identified as " Reggie Ford." Mr. Ford played in the National Football

League along with Mr. Stacy. Ms. Evans stated that "Mr. Ford" attempted to "hit on her," but she refused his advances. Ms. Evans went to the hospital to get treatment for her injuries on the same day.

During my investigation, I observed video that was recorded by the victims' surveillance system. I observed Stacy strike the victim twice to the back of her head with the first strike with an unknown object in his hand. The second strike was with a closed fist to the back of the head, with such force knocking the victim to the floor. Stacy then picked up the victim like a "rag doll" and threw her into a 65-inch television. As a result, the victim struck the television fell to the floor, and the television fell on top of her, causing injury. While the victim was on the floor, Stacy approached her in a threatening manner with his fist clenched, and she balled up in a defensive manner. He went back to the couch and grabbed an object in his right hand. He walked back to Evans while she was still on the floor and threw the object at her, which struck her in the front of the head. While she was still on the floor pleading with him to stop, he picked her up and body-slammed her down onto a baby walker, causing the object to break as she fell.

During the entire altercations, Evans tried to remain calm and talk to him. However, during this time, she kept pleading to him to please stop.

As a result of the physical dispute, Mr. Stacy did cause injury to Ms. Evans. She received a contusion to her face, bruises to her torso, contusion to her left leg, and abrasions to her right leg. In addition, her television was valued at 1,000.00 USC, and a baby bouncy was damaged at the time of the incident.

There is probable cause to charge Mr. Zackary Stacy with Aggravated Battery F.S.S. 784.045. Mr. Stacy did commit the offense of Aggravated Battery by intentionally and knowingly causing great bodily harm to Ms. Evans by continually slamming her body into a solid object and striking her in the head multiple times.

There is probable cause to charge Zackary Stacy with Felony Criminal Mischief F.S.S. 806.13. (1)(b)(3). Mr. Stacy did willfully and maliciously cause damage to Ms. Evans's personal property (65-inch T.V. and baby bouncy) valued at over \$1,000.


On 11/15/2021 Ms. Evans submitted for a protection order through the Orange County Court. As of 11/16/2021 Ms. Evans advised us that the protection order was signed by a judge and is pending being served to Mr. Stacy.

On 08/16/2021, we responded to the same address in reference to a verbal dispute. The dispute was with Mr. Stacy and Ms. Evans.




