Probable Cause

On April 23, 2022, at approximately 6:00PM; I was traveling east on State Road 56, in the area east of Meadow Pointe Drive. I observed a large cloud of smoke in the area of the median break between eastbound and westbound lanes of State Road 56. I heard the sound of squealing tires and saw the cloud of smoke, which reduced the visibility to nearly zero for traffic on the westbound lanes of State Road 56. I observed an orange in color Dodge Challenger emerge from the smoke in a westbound direction. I could smell the distinct smell of burnt rubber as I proceeded to turn around in the same median break. I observed a series of tire marks on the roadway consistent with a vehicle performing "a donut". The orange Dodge Challenger proceeded to turn north on Meadow Pointe Drive and turn east onto Driscoll Drive. I conducted a traffic stop on the 2016 Dodge Challenger SRT Hellcat with Florida Tag "T36FZ", on Driscoll Drive. As I approached the driver's side of the vehicle, I observed the area of the rear wheels had fresh rubber particles attached the orange body panels. The driver was identified by his Florida License as Byron Pringle (defendant) DOB 11-17-1993. The vehicle was occupied with an adult passenger in the front right seat and a male juvenile child in the left rear seat. A check of FCIC / NCIC revealed Mr. Pringles Florida Drivers License was currently suspended for financial Responsibility as of February 10, 2022 with a seize tag order and another suspension failure to pay a traffic fine as of March 7, 2022. DAVID shows notice of suspension given as of February 14, 2022. The 2016 Dodge Challenger was registered to Byron Pringle (Defendant) and showed a valid registration.

Deputy Allman #5597 of the Pasco County Sheriff's Office responded to the scene as a back up officer at approximately 6:13PM. I informed the defendant he was being placed under arrest for Reckless Driving and ordered the defendant to exit his vehicle. The defendant ignored my verbal commands initially then became verbally confrontational. The defendant was placed under arrest at approximately 6:15PM.

I seized the license plate from the defendant's vehicle. The 2016 Dodge Challenger was removed by Atlas Towing. The defendant was transported to the Pasco County Jail and charged with Reckless Driving and DWLSR without further incident.
