On 5/11/22, Rajon was in my home playing video games with our son, [REDACTED] I asked [REDACTED] to finish separating his laundry so that I could finish washing clothes. Rajon responded that [REDACTED] was playing video games with him. I asked [REDACTED] to please separate his clothes as it would take less than five (5) minutes, and then he could return to playing the game. When [REDACTED] got up to do what I asked, Rajon became enraged and ripped the video game console from the wall in [REDACTED] presence, scarring him in the process. Rajon then went downstairs to the kitchen where I had prepared some tea for our sick daughter, [REDACTED] Rajon took the tea cup and plate and smashed it. Rajon also knocked over several water bottles and was generally yelling and cursing. He then went into the home office and began to knock over various items. He then went outside and knocked over the trash cans, stomped on the pathway landscaping lights, and then pulled his car onto the [REDACTED] lawn. The children were extremely upset and distressed with having seen Rajon become so enraged and violent. I attempted to deescalate the situation by asking Rajon why he was acting this way. Rajon responded by threatening my life, saying "You're dead." This is not the first time that Rajon has made threats to kill me.

I went back into the home and went upstairs with the children. I called former police chief Yvette Gentry for assistance. I did not call the police because I was fearful of what Rajon might do if a formal report was made. I was concerned that Rajon's rage would become even more exacerbated and could lead to him harming myself or the children. After I called Ms. Gentry, I believe that Rajon left the home.

However, approximately fifteen (15) minutes later, Rajon returned by once again driving his car through his backyard (an adjacent property) to my backyard. He began beating on the backdoor window with his gun. I was in my room located on the main floor. I couldn't immediately figure out what was going on, so I went into the family room. There, I saw Rajon beating on the backdoor window with his gun in his hand. I yelled to him that he was scaring me, to which he yelled back, "Go get my fucking son."

I did not know what to do, and I was fearful of what Rajon would do if I did not obey his order. I went upstairs and got [REDACTED] and allowed Rajon to see him through the door. Rajon continued to yell and demanded that he speak to [REDACTED] I did not know what to do, and before I knew it, [REDACTED] began to opening the door. Rajon then grabbed [REDACTED] yanked him outside, and slammed the door shut behind him. Rajon slammed the door so hard, that it knocked over and broke and battery box for my outdoor shade. Rajon began yelling and cursing at [REDACTED] and asking him why he was afraid of him. Rajon continued to hold his gun in his hand while yelling at [REDACTED] I did not intervene because I was afraid that I would be shot if I attempted to do so.

[REDACTED] was visibly upset.

Rajon then demanded that [REDACTED] go back inside to find Rajon's cell phone. Rajon demanded that [REDACTED] return with his iPad so that he could call Rajon's phone, which was later found in his car. Rajon, still holding the gun, then demanded that [REDACTED] go get his sister. Soon, Rajon was yelling and cursing at both children, demanding to know why they were scared of him and effectively holding them at gun point. The children were visibly upset and clearly scared that Rajon continued to brandish his gun. Our daughter told Rajon was upset because he had a gun with him. Rajon could not be calmed down by either William Rondo or Douglas Bibby, or even his own mother, all of whom had arrived after Rajon to apparently try to calm him down at least enough to let the children come back inside. Once Rajon did allow the

children to come inside, they were extremely upset and fearful of what was going on. They were crying and I tried to comfort them.

Soon after, Yvette Gentry arrived, and asked that I let her in the home. I tried to let her in, but Rajon blocked her from entering by standing between her and the door. Rajon continued to brandish his gun, so I decided to lock all the doors and garage, and remain upstairs with the children. Sometime later, Ms. Gentry confirmed that Rajon had left and that she now had possession of his gun.

I am extremely fearful for my safety and for the safety of my children. Rajon has a history of volatile, erratic, explosive behavior. He is verbally, emotionally, and financially abusive. He physically hits our son and calls him names like "pussy" and accuses him of acting like a "bitch." Rajon verbally assaults our daughter. He calls her names like "thot, bitch, and dickhead." Rajon has made several threats on my life, saying at various times that he will shoot me or shoot up my car. I am beyond fearful that Rajon will return and attempt to harm myself or the children and make good on his threats to end my life. I am seeking immediate protection for myself and the children from any further contact from Rajon, for temporary sole custody of the minor children, and for the entry of a formal domestic violence protective order.

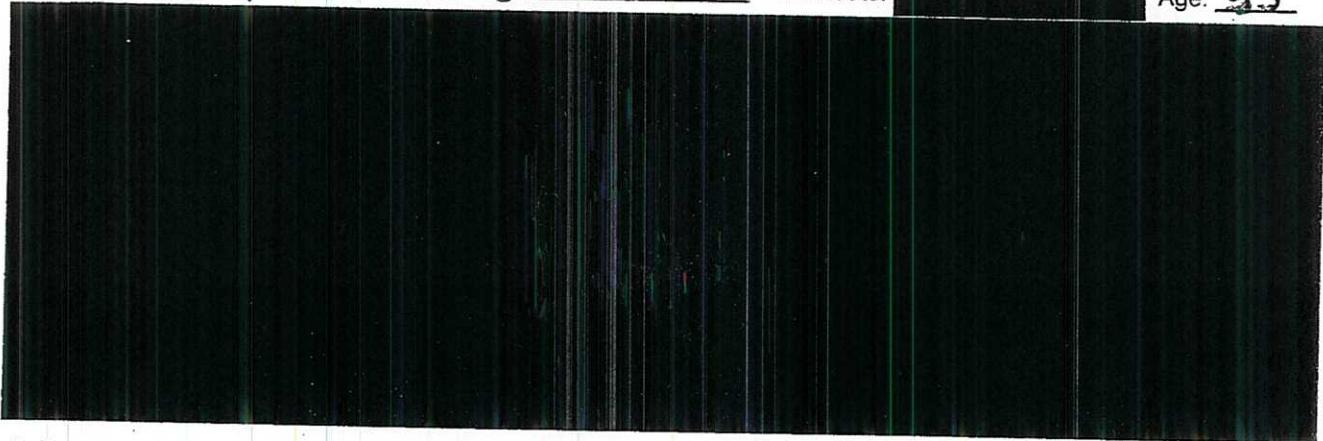
