**Probable Cause**

On 11/08/2021, at approximately 1945 hours at [REDACTED] in Escambia County, Florida, Joseph Zolciak did knowingly and intentionally commit the offense of Battery (Domestic Violence) by pushing his wife (Karen Zolciak), who he currently resides with as family, which caused her to fall and hit the side of her head on an antique table, the facts are as follows.

On 11/08/2021, I responded to [REDACTED] in reference to a Disturbance

Upon my arrival, I made contact with V/Karen Zolciak who provided the following sworn verbal statement under oath. V/Karen Zolciak stated on today's date, she and her husband later identified as S/Joseph Zolciak got into a verbal argument over him talking to a female neighbor, before he left in his vehicle to go drop off HOA paperwork at another neighbor's residence. V/Karen Zolciak stated she did slam the front door of her residence because she was upset about S/Joseph Zolciak talking to the female neighbor. V/Karen Zolciak stated S/Joseph Zolciak then return back to their residence where a verbal argument began over him talking to the female neighbor. V/Karen Zolciak stated S/Joseph Zolciak was ignoring her and watching TV in the bedroom, so she decided to go take a bath. V/Karen Zolciak stated once she was done with her bath, she then attempt to talk to S/Joseph Zolciak about the situation but he then had got up and went to the living room for the night. V/Karen Zolciak stated she then went to the living room to talk to S/Joseph Zolciak again. V/Karen Zolciak stated that is when S/Joseph Zolciak pushed her, causing her to fall and hit the right side of her head on an antique table. V/Karen Zolciak stated she then got up and called Law Enforcement. V/Karen Zolciak stated she had two glasses of wine. I could tell while having a conversation with V/Karen Zolciak, that she was highly intoxicated.

I observed V/Karen Zolciak to have a minor cut on the right side of her head. I also observed the minor cut to be bleeding. V/Karen Zolciak was also complaining of injury to her right arm, but I didn't observed any injuries. EMS Medic 64 resopned and transported V/Karen Zolciak to West Florida Hospital.

I then made contact with S/Joseph Zolciak who stated the following. S/Joseph Zolciak stated V/Karen Zolciak got upset that he was talking to a female neighbor just before he was leaving to go drop off HOA paperwork at another neighbor's residence. S/Joseph Zolciak stated V/Karen Zolciak then slammed the front door of their residence, which got his attention that she was upset that he was talking to the female neighbor. S/Joseph Zolciak stated he then got into his vehicle to go drop off the HOA paperwork. S/Joseph Zolciak stated he then return home and V/Karen Zolciak began yelling at him and slamming doors because he was talking to the female neighbor. S/Joseph Zolciak stated he decide to ignore V/Karen Zolciak and watch TV in their bedroom. S/Joseph Zolciak stated V/Karen Zolciak then went to take a bath and left him alone for the time being. S/Joseph Zolciak stated after V/Karen Zolciak was finished with her bath, she continued to yell at him about him talking to the female neighbor. S/Joseph Zolciak stated he then decided he was going to sleep in the living room. S/Joseph Zolciak stated while sitting in the living room watching TV, V/Karen Zolciak made her way to the living room and began yelling at him again. S/Joseph Zolciak stated V/Karen Zolciak stood right in front of

him blocking his view from the TV. S/Joseph Zolciak stated he then ask V/Karen Zolciak to move out of his way to watch TV, but she didn't. S/Joseph Zolciak stated he then slightly pushed V/Karen Zolciak, out of his way so he could continue to watch TV. S/Joseph Zolciak stated V/Karen Zolciak then fell when he had slightly pushed her. S/Joseph Zolciak stated he didn't realize V/Karen Zolciak hit her head, until after Law Enforcement was contacted. S/Joseph Zolciak stated he was ignoring V/Karen Zolciak the entire time. S/Joseph Zolciak stated he and V/Karen Zolciak have been married for 45 years and have two children in common. S/Joseph Zolciak stated V/Karen Zolciak was intoxicated, so he believes that is why she fell.

I then completed a domestic violence questionnaire with V/Karen Zolciak, where she provided the following risk factors:

- Gun present in home or accessible to the suspect.
- Suspect attempts to control partner's activities.
- Suspect abuses alcohol.
- Suspect threatens to kill victim.

I then provided V/Karen Zolciak a victim constitutional rights brochure, a victim rights brochure, and a notice of legal rights and remedies with my name and case number. I also completed a domestic violence notification form and provided V/Karen Zolciak her copy.

There were no witness's.

I took multiple photographs of V/Karen Zolciak and S/Joseph Zolciak, which will be uploaded to QueTel.

V/Karen Zolciak and S/Joseph Zolciak couldn't provided me any video evidence of the incident.

S/Joseph Zolciak was then placed under arrest and transported to Escambia County Jail and given a County Court date of 11/29/2021 and NO BOND for Battery Domestic Violence per Florida Statute.

My body camera was activated during this incident, which will automatically be uploaded to the Sheriff's Office server with the correct case number.
