STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Your Complainant is a licensed peace officer in the State of Minnesota and is employed by the Stillwater Police Department. In that capacity, your Complainant states the following to establish probable cause:

On 07-05-2015, Saint Paul Police Department was dispatched to the area of Edgerton Street and Case Avenue on a report of an Asian woman intoxicated. The caller, later identified as A.C., stated that an Asian woman was lying on the sidewalk and appeared to be intoxicated. A.C. said that she was unable to provide her name so he called 911. A.C. said that when he turned around, a green Chevrolet pickup truck pulled up and a white male in his 20's got out and made contact with the female. A.C. said the male picked up the female and put her in his truck. A.C. stated that the male got into his truck and drove away fast—almost hitting another vehicle.

Law enforcement also made contact with C.H. C.H. stated that he was looking out a west facing window of his home and saw an Asian female lying on a sidewalk next to the telephone pole. C.H. believed the female to be unconscious. C.H. saw a red car pull up to check the welfare of the female. C.H. then saw a male walking away from a green truck. The male was described as being five-feet, eight-inches tall and was wearing dark colored jeans and a dark hoodie. The male had the hood of the hoodie pulled over his head. C.H. then observed the male pick the female up and carried her to his green truck. While he was picking up the female up, C.H. observed the female as being "limp and lifeless." C.H. then went outside to confront the male. However the male in the green truck backed out the parking space and almost hit a garage. The green truck then sped away with its headlights off. Sgt. Stender made contact with the supervisor at the Saint Paul Police Department. Sgt. Stender learned that a witness identified the suspect green truck parked in a nearby parking lot, backed in a dark area with its lights off prior to the incident.

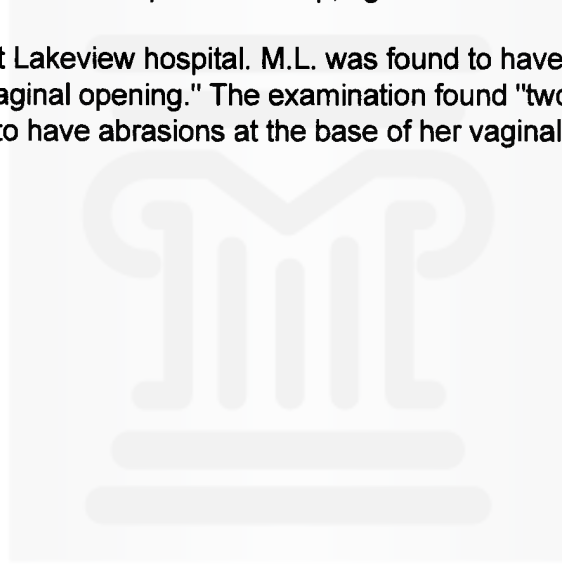
A.C. was able to provide a license plate number (MIN LIC: 226 OWL). Further investigation revealed that a green Chevrolet pickup truck was registered to A.N. with the plate number of "226 LWL." Law enforcement made contact with A.N. who stated that he had sold his vehicle two months ago to "Jeremiah Johnson." Law enforcement was able to identify the male as JEREMIAH DANIEL JOHNSON (DOB: 01-24-1989), the defendant herein. It was discovered that the defendant was living at 1504 Greeley Avenue South, Apartment 6, in the City of Stillwater, Washington County.

Stillwater Police Officer Felsch and members of the Saint Paul Police Department located the vehicle. The vehicle was parked in front of the defendant's residence. The vehicle matched the description given by witnesses. Upon making contact with Apt. 6, law enforcement discovered the Asian female, M.L. in the common hallway of the complex. M.L. did not know where she was and seemed "frightened and confused." M.L. stated that she was intoxicated and the last thing she remembers is watching the fireworks. M.L. said that she woke up on an air mattress with her bra and underwear on next to a guy she didn't know. M.L. stated that due to her intoxication she "blacked out." M.L. stated that something "may have happened" because she had concerns around her vaginal area.

Sgt. Stender attempted to make contact with defendant and Apt. 6. After numerous attempts were made by knocking on the door, the defendant answered. The defendant was arrested. A search of the residence yielded an unwrapped condom, condom wrapper, numerous items of clothing and bedding. Forensic examination of the evidence recovered has been submitted to the BCA and results of the examination are pending.

The defendant stated that he "wanted to help" the female because she had sprained her ankle. The defendant stated that she walked over to his truck and he helped her in. The defendant stated that she was "drunk" and she began to vomit. The defendant acknowledged others parties who were attempting to assist her. The defendant stated she walked to the truck with his assistance. The defendant stated that the female couldn't give her address so he took her to his apartment in Stillwater. The defendant initially denied any sexual contact. The defendant eventually admitted he "tried to do a little something, but it didn't work." The defendant admitted that he was drinking, however, "wasn't that drunk." The defendant also stated "say we did have sex, she is 18, and there is nothing illegal about that." The defendant said that "he always wanted to do and Asian girl" and "now that I picked one up, I get arrested."

M.L. was examined by a nurse at Lakeview hospital. M.L. was found to have "generalized redness throughout her labia and at the vaginal opening." The examination found "two hematomas" located on her inner labia. M.L. was also found to have abrasions at the base of her vaginal opening and between her vagina and anus.
