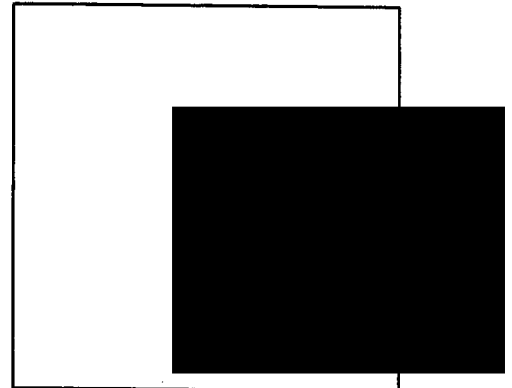

Affiant's reasons for so believing are as follows:

Your affiant has thirteen years of professional law enforcement experience with the Jacksonville Sheriff Office.

On Tuesday 07-18-2017 between the hours of 1300-1400 the defendants; Tyler Packar Ward, James Patrick Palmeter and an unknown black male; burglarized an unoccupied structure located at 2425 Ormsby Court, Jacksonville FL 32210. The point of entry was made by entering a rear back window and unlocking the rear door. The victim works in Orlando Florida and was not home at the time of the burglary. He said he has a surveillance camera system on his home and on 07-20-17 he was trying to check his camera system and noticed it was off-line. He then contacted a relative and asked him to check on his residence. When the relative checked the residence, he found it to be ransacked. He contacted the victim who then returned to Jacksonville.

The victim was able to verify the stolen items from his home to include a Beretta handgun, PTR semi-automatic rifle, HP laptop and several vehicle keys. Crime Scene Detective responded to the scene and took overall photos. No lifts of value were obtained.

The victim reviewed his surveillance camera system and saw the above listed defendants inside his residence. He could see the defendants were wearing gloves. He then took snapshots of their face and sent them out via Facebook prior to this case being assigned to a Burglary Detective.

Prior to reviewing the video surveillance, several tips came in concerning the identity of the unknown individuals in the photos shared on Facebook. It was discovered Tyler Ward and James Palmeter are associates and worked together for Kirby Company by Nelson. After viewing the video surveillance, the defendants can be seen looking directly at the camera. These facial photos helped to identify the defendants via prior arrest databases.

It should be noted, Tyler Ward has an active warrant for a business burglary (ccr# 17-400585).
